- Once the above funding is approved the draft ILA will go to legal review by each respective entity as necessary.
- A second vote will be put on future council agendas to approve the ILA once it has been reviewed and finalized by legal counsel.
- Focus for this planer should start with a review of trail master plans to ensure continuity and shared direction between all entities.
- Moving forward objectives will be identified that can best benefit the community in the very near future and demonstrate the success of the position.
- Future scope of work could include motorized trails and connectivity.
- With success, more funding could be acquired to expand the responsibilities, scope and hours of the trail planner.

I will keep everyone copied here posted as we move through the first round of Council meetings. Once we have the necessary approvals, we can look at setting another meeting to set dates for approval of the ILA, and initial wishes/scope of work for the future trail planner.
