Subject: Memo Regarding Midway City Standard Roadway Widths

Mayor and City Council,

We met with Councilmen Simons, Councilmen Payne, and the planning staff regarding the Midway City standard roadway widths. The engineering department supports the proposed changes however our recommendation for local rural street asphalt cross section be increased from 20' to 22' of asphalt. Below is a summary of our discussion with the attached cross sections:

- 1. Local Street Cross Section #1 for Commercial Business
 - a. It is proposed to leave the asphalt cross section as shown. This will accommodate parking and allowing vehicles to open doors without causing issues for cars driving on the street.
- 2. Local Street Cross Section #2
 - a. Reduce the required cross section width of asphalt from 30' to 26'.
 - b. Take the reduction in asphalt width and add it to the park stirp. This would take the park strip from 5' wide to 7' wide.
- Local Street Cross Section #3
 - a. Reduce the required cross section width of asphalt from 30' to 26'.
 - b. Take the reduction in asphalt width and add it to the park strip.
 - c. With a only a trail on one side of the road.
 - d. The road is shifted to the left so that the left side of the cross-section distance from the curb and gutter to the ROW equals the right-side distance of the outside edge of the trail to the ROW.
- 4. Local Rural Street Cross Section #4
 - a. To qualify for this cross section the frontage requirement has been reduced from 150' to 105' and must be approved by City Council.
 - b. Reduce the required cross section width of asphalt from 30' to 20'. With a 2' ribbon curb on each side.
 - c. Take the reduction in asphalt width and add it to the park strip.
 - d. With a only a trail on one side of the road.
 - e. The road is shifted to the left so that the left side of the cross-section distance from the curb and gutter to the ROW equals the right-side distance of the outside edge of the trail to the ROW.




