## **Midway Arts Center Highlights**

- 450 Seat Main Stage Slightly less than the number of patrons who, every night, attended our recent "Seven Brides for Seven Brothers' performances. Though Main Street Midway was closed and the cars routed throughout Midway, traffic caused no known issues.
- Youth Program performers are already rehearsing and performing in Midway in the same general numbers as will rehearse and perform in the Midway Arts Center.
- Youth Show Audiences are already attending the Town Hall for youth productions in the same general numbers that will attend the Midway Arts Center.
- **Superb Audience/Cast Experience** The Midway Arts Center will provide a superb experience for casts and audiences with:
  - stadium seating;
  - a full-size stage for professional sets;
  - professional sound and lighting;
  - o unique LED scenery backwall instead of a 70-foot fly;
  - seasons tickets to develop an ongoing clientele who will participate in regular fundraisers, helping assure that The MAC will be a viable business venture.
- **Community Use** The MAC Main Stage will be available approximately 90 days/year for use by community arts organizations. The youth theater venue will be available more than 90 days/year.
- Frequency of Performances The frequency of performances will increase, but the <u>per</u> <u>performance traffic load</u> will not increase to numbers any greater than is currently operational in Midway with the exception of the Christmas show. This show is sometimes lower in total numbers than the summer show. We expect it to ultimately increase to equal the attendance of "Seven Brides", an event which caused no traffic issues.
- Increased frequency of performances will allow resorts and restaurants to host yearlong, ongoing clientele instead of the sporadic, seasonal clientele they now experience, which will help them achieve financial success.
