and professional staff and thankful for community


leaders and partners. I am deeply proud of how Wasatch County responded, pulling together to generate tremendous resilience.

HEALTH DEPT. OPENS COVID TEST SITE TO MEET DEMAND



Recognizing the limited availability of COVID testing in Wasatch County, the health department opened a test site in August 2021 on the north end of the community services complex. This site offers both rapid antigen and PCR testing free of charge to the general public. Appointments are required; however, there are no restrictions on who can get tested. It is anticipated this site will operate until Spring 2022.

HEALTH EQUITY TEAM TO ADDRESS DISPARITIES

Having identified gaps in services and accessibility among some members of the community, particularly during the COVID-19 pandemic, the health department established a health equity team to address disparities. Health equity means everyone has a fair and just opportunity to be healthy. The team's action plan includes the following objectives:

- Identify vulnerable populations
- Identify gaps in resources and develop solutions
- Gather available resources and services

- Bring awareness to available resources
- Promote policies that improve health outcomes

To help achieve these objectives, the health equity team coordinates with partner organizations, including: the Wasatch Community Foundation, the Christian Center of Park City Food Pantry, Community Action Food Bank, and Wasatch County School District. Members of the team also serve on the Wasatch Latino Coalition, Senior and Caregiver Coalition, and the Caring Community Coalition.

A project of note from 2021 was the team's participation in the 5th annual Wasatch County Clothing and Toy Exchange. Many people in need were able to get clothes and toys in time for the holiday season. Donated items not claimed by the end of the event were given to participating youth groups for their own fundraising efforts and a refugee program in Salt Lake City.

FOG AGREEMENT WITH HEBER CITY

In a cooperative effort to reduce the amount of fats, oils, and grease (FOG) entering wastewater and drainage systems, the health department and Heber City signed a joint service contract/MOU during the fall of 2021.

As part of this agreement, environmental health inspectors will review compliance with the city's FOG ordinance during their routine inspections of food service establishments within Heber City. Any noted violations of the ordinance are referred to the city's public works department for follow-up.

ILIGHTS FROM THE YEAR

WIC REACHES THOSE IN-**NEED WITH MOBILE CLINIC**



During 2021, the Women, Infant, and Children (WIC) program began offering mobile clinics in outlying areas of Wasatch County to meet the needs of those who are least able to travel to the health department for WIC services, utilizing a van purchased and outfitted

Based on an evaluation of the initial clinics, a regular schedule was established - WIC staff now provides a mobile clinic at the Todd Hollow housing complex once per month. Feedback from clients shows an appreciation for later hours and easy access from their home. In addition to WIC services, the mobile clinic has been used to concurrently provide immunizations.

HEALTH DEPT. HOSTS 3RD ANNUAL CHILDREN'S CLINIC

The health department hosted the 3rd annual Children's Health Clinic in August 2021, with the theme "Super Healthy Kids." This event, put together in partnership with: Wasatch Community Foundation, Intermountain Healthcare. People's Health Clinic, Wasatch County School District, and Wasatch Behavioral

Health, offers free services to children who are not covered by health insurance.

The event provided well-child exams, dental care, immunizations, and hearing and vision screening. A social emotional screening was also including this year. Spanish-speaking volunteers served various roles as translators, guides, and facilitators to help children access services and sign up for Medicaid if they qualified.

The health department appreciates all of those who volunteered their services. including providers from Intermountain Healthcare, People's Health Clinic, The Hope Alliance, and local dentists: Dr. May and Dr. Ogilvie.

COVID-19 MASS **VACCINATION CLINICS**


Following successful efforts to provide first doses of COVID vaccine to CDCidentified priority groups in December 2020, the health department and county emergency management set up drivethru mass vaccination clinics for the general public beginning January 2021.

The drive-thru model was chosen due to its effectiveness in vaccinating large numbers of people quickly while minimizing potential exposure of staff and clients to pathogens. To help operate the clinics, the department activated volunteers from the Medical Reserve Corps (MRC), hired temporary staff members, and partnered with the Utah National Guard and Wasatch County School District.

The high-volume clinics were open through May 2021, and again briefly in the fall of 2021, administering more than 20,000 doses of vaccine.


