4. HVSSD / Industrial Protection Area (City Attorney – Approximately 20 minutes) – Receive a presentation and discuss an industrial protection area proposed by the Heber Valley Special Service District (HVSSD) for its sewer treatment facility located at 1000 East Main Street, Midway.

Corbin Gordon made the following comments regarding industrial protection areas (IPAs):

- The City could file a protest to an IPA within 15 days of the date of notice.
- A county council had broad discretion when considering an IPA.
- IPAs governed normal uses but not issues of health and safety.
- The Council needed to give him guidance if they wanted him to file a protest of the HVSSD's possible IPA.
- The City could not stop an entity from applying for an IPA.
- IPAs could cross jurisdictional boundaries.

Mayor Johnson, who was also the HVSSD Board Chair, told the HVSSD Board that the Midway City Council would like several things done before an IPA was sought. She added that Heber Light & Power Company and the Jordanelle Special Service District might also apply for IPAs.
