Brad Wilson gave a presentation on the proposed tentative budget and made the following comments:

- The budget had zero balances because the 42 West Main Street project had concluded.
- Had met with Board Chair Johnson and the Wasatch Mountain State Park Superintendent regarding a potential project area for the State Park's campgrounds.
- Could not find any evidence that taxes from the campgrounds were being paid to Midway City. The Superintendent would verify if that was the case.
- If the taxes were continuing to go to the County, then that could continue to be the case and a project area was not needed.
- If the taxes were coming to the City then a project area was needed and the taxes needed to be reimbursed to the State Park.
- Once this was determined then the future of the CDRA could be considered.
