

# Midway City Corporation



Dear Resident:

I appreciate your interest in running for elected office. Citizen participation is essential to the success of the United States and its political system.

The following information will help you as you consider serving:

## **Candidate Qualifications**

- Registered voter in the municipality in which the individual is elected.
- Resided within the municipality for which the candidate is seeking office for 12 consecutive months immediately before the date of election.
- If the individual resides in a territory which was annexed into the municipality: must have resided within the annexed territory of the municipality the 12 consecutive months immediately before the date of the election.
- Maintain their primary place of residence within the municipality that the elected officer represents, during the officer's term of office.
- In accordance with the Utah Constitution, Article IV, Section 6, a mentally incompetent individual, an individual convicted of a felony, or an individual convicted of treason or a crime against the elective franchise may not hold office in Utah until their right to hold elective office is restored.

## **Election Dates**

- Filing Period – June 2<sup>nd</sup> – June 6<sup>th</sup>
- Primary Election (If needed) – August 12<sup>th</sup>
- General Election – November 4<sup>th</sup>

## **Campaign Regulations**

- **Campaign finance statements must be submitted at regular intervals during the Primary Election (If held) and the General Election.**
- Midway City permits temporary political signs only for officially recognized candidates in a current, ongoing election. Such signs are prohibited on public property, in street rights-of-way and in sight view triangles at intersections. Such signs shall not interfere in any way with or confuse traffic or present a traffic hazard. They can be a maximum of 20 square feet and do not require a permit. Do not put them on utility poles or traffic/street signs. All political signs must be removed within 72 hours after the General Election.

- Main Street, Center Street (South from Main Street), Highway 113, 200 West (from Main Street to 200 North), 200 North (from 200 West to Homestead Drive), Homestead Drive and Highway 222 are State roads and subject to UDOT regulations regarding political signs and campaigning.
- Political signs and campaigning are prohibited within 150 feet of a polling location.
- Political signs and campaigning are regulated by various entities, such as homeowners' associations, and further regulations may apply.

### **Service**

- The positions of mayor and two council members are open for election in 2025.
- Each serve for a term of four years.
- A council meeting is held on the first Tuesday of each month at 6:00 p.m.
- A second council meeting is held on the thirteenth Tuesday of each month at 5:00 p.m.
- Council meetings may be held on other dates and times as necessary.
- The Mayor is currently paid \$27,037.50 annually.
- Council members are currently paid \$16,222.50 annually.
- The mayor and council members may participate in the City's health insurance program if they pay the monthly premium.
